PRIVACY POLICY

The type of personal information we collect:

- Personal identifiers, contacts and characteristics (for example name and contact details).

How we get the personal information and why we have it:

Most of the personal information we process is provided to us directly by you for one of the following reasons:

How and why we store your personal information:

Your information is securely stored locally in digital and/or paper format. We keep the data we hold for up to five years. The reason we hold the data is to facilitate repeat orders or advise that a Re-Start is available to a school. After this point if no communication is received we will delete the data we hold on digital files. Paper copies are held for a period of seven years to meet our commitment to HMRC.

Your data protection rights:

Under data protection law, you have rights including:

<u>Your right of access</u> – You have the right to ask us for copies of your personal information

<u>Your right to rectification</u> – You have the right to ask us to rectify personal information you think is inaccurate or incomplete

<u>Your right to erasure</u> – You have the right to ask us to erase your personal information in certain circumstances

<u>Your right to restriction of processing</u> – You have the right to ask us to restrict the processing of your personal information in certain circumstances

<u>Your right to object to processing</u> – You have the right to object to the processing of your personal information in certain circumstances

<u>Your right to data portability</u> – You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you

If you have any concerns about our use of your personal information, you can make a complaint to us
